Letter #8 to the Mayor and City Councillors

Mayor Brown, Deputy Mayor Jankov, Councillor Muttart, Councillor Beck, Councillor Tweel, Councillor Ramsay, Councillor Doiron, Councillor McAleer, Councillor MacKinnon, Councillor McCabe and Councillor Bernard.

Today is day 23 of the strike. We sent seven letters requesting an urgent meeting with the Mayor, the Councillors and the CAO. We have not received a response. We emailed three letters to each of the following Standing Committees: Human Resources, Water and Sewer Utility, and Finance, Audit, Tendering & Administration. We have not received a response. This is our eighth correspondence to you. We deserve a response to our requests.

We are valuable and dedicated workers. We love our jobs and this City. We have sacrificed our time with our families, our children's sports, our Holidays, and gatherings with our friends. We work 24/7, year-round and in all weather conditions, through hurricanes, winter storms and hot humid days. The love for our City goes beyond our work. For instance, one member is a volunteer firefighter and left the picket line today to answer a call. That's the love we have for the City.

We are asking you for the umpteenth time to stop avoiding your duties and ignoring this situation. You were elected by the residents of the City of Charlottetown. You must use your elected power to direct the Chief Administrative Officer and the City's bargaining team to review the budget, to change their position on the key issues, and to come back to the table with a fair offer.

Services are currently not being provided to residents, and they are frustrated by the City Council's inaction. Many residents visited our headquarters, sharing their frustrations about the Council's total disregard of this situation and their support for CUPE Local 830.

Water and sewer workers are currently visiting neighbourhoods across Charlottetown delivering information (see postcard attached) and having conversations. And we will tell you, the support for us is overwhelming. These are your constituents, and you have either heard from them or should be hearing from them soon.

The recent news of the Air Canada flight attendant's tentative agreement is a display of a strong organized labour union with 770,000 members from coast to coast to coast. That is CUPE. And CUPE Local 830 has support from across the country (see letter of support attached). The National President of CUPE, Mark Hancock, stated during his visit to the beautiful City of Charlottetown a few weeks ago, "We will support these members until their collective agreement is found at the bargaining table. We will put any resources needed. We will keep fighting until we get a collective agreement that works for our members." (see videos attached)

CUPE Local 830 will continue to fight for job security and seniority rights, and for fair wages for our members. We deserve respect and fairness for our work.

We will not back down.


Why we are forced to strike:
